The Court now stays the effect of the March 14 Opinion and Order, nunc pro tunc to March 14, 2024, until the Court issues an order on Plaintiffs' forthcoming motion concerning whether notice should be provided by the Court to members of the class that was certified under Rule 23(b)(2).
